## POLICY STATEMENT ON BEHALF OF PROTECTED VETERANS AND INDIVIDUALS WITH A DISABILITY \_\_ 41 CFR §§ 60-300.44(A), 741.44(A)

In alignment with our WireCo Business System (WBS) and its behaviors to foster a connected culture for all, it is the policy of WireCo not to discriminate against any employee or applicant for employment because he or she is a qualified individual with a disability, a disabled veteran, a recently separated veteran, an active-duty wartime or campaign badge veteran, an armed forces service medal veteran (protected veterans) or a spouse or family member of a protected veteran.
